The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting, and will encourage them to attend, by:
-School Monthly calendar, the one call messenger system and the parent resource center order form where the parents can receive up to ten booklets on various topics of their choice.

4. The **Menallen Elementary School** will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:
-Send PSSA parent letter with first report card, progress report, benchmark assessments were sent home, students using and having access to study island and Dibels.

5. The **Menallen Elementary School** will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:

-Parent/Teacher conferences, Planned Visitation Policy, conferences during prep period and IEP meetings and SST's. Parents are able to email or call the parents when needed.

6. The **Menallen Elementary School** will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:

-PSSA parent letter sent home with the report card, benchmark assessments sent home, study island and Dibels.

7. The **Menallen Elementary School** will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:

8. The **Menallen Elementary School** will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --

9. The **Menallen Elementary School** will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

-Parent Portal training on November 9th during the open house provided by administration, Reading Literacy Club and the Title 1 parent resource center order form.

10. The **Menallen Elementary School** will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

-Act 80 Day video training, teachers evaluated on relationships with the parents, there is great parental support at the school and the teacher's support the fundraisers. There is also a playground committee and a recycle rally.

11.
